NOTIFICATION

Whereas, the State Election Commission had notified the by –election schedule to fill up the vacant post of Ward Members, Sarpanches, Panchayat Samiti Members and Zilla Parishad Members of different Districts vide Commission's Notification No. 352, 367, 378 & 360 all dated 05.02.2020. The date of poll fixed to 20.03.2020 was subsequently shifted to 24.03.2020 in view of the HSC Annual Examination;

Whereas, in view of the situation arising due to COVID-19, the process of by-election was postponed vide Commission's Notification No. 850 dtd. 16.03.2020;

Whereas, the process of the ensuing by-election has been completed up to publication of final list of contesting candidates and was postponed before poll;


Now, therefore, the State Election Commission in exercise of powers conferred under Article 243K of Constitution of India, read with Section 16 of the Odisha Gram Panchayat Act, 1964 and Rule 85(1) of the Odisha Gram Panchayat Election Rules, 1965, Section 47 (1) of Odisha Panchayat Samiti Act, 1959 and Rule 46(1) of Odisha Panchayat Samiti Election Rules, 1991 and Section 40 of Odisha Zilla Parishad Act, 1991 and Rule 61 (1) of Odisha Zilla Parishad Election Rules, 1994 hereby appoints the following dates and time for poll of the by-election to be held in respect of Ward Members, Sarpanches, Panchayat Samiti Members and Zilla Parishad Members of different Districts except in the containment Zone area declared by the competent authority.




The contesting Candidates are to be intimated by the Election Officer in writing regarding the revised poll schedule.


