Whereas, the State Election Commission, Odisha issued Notification Nos.1149 and 1164 all dated 22.03.2021 to hold by-election to the office of the Panchayat Samiti Members, Sarpanches and Ward Members and the date of poll is 28.04.2021;


Whereas, in view of the present situation arising due to the resurgence of SARS-COV 2 and to prevent the transmission of the Covid 19 virus, the process of ensuing by-election has been postponed vide Commission's Order No. 1358 dtd.16.04.2022 until further orders;

Whereas, as per the provisions under Odisha Grama Panchayat Election Rules, 1965 and Odisha Panchayat Samiti Election Rules, 1991 where there is only one candidate for the election of Panchayat Samiti Member, Sarpanch and Ward Member, the Election Officer shall declare the name of such person duly elected uncontested;

Now, therefore, the State Election Commission in exercise of the powers conferred under Article-243-K of the Constitution of India and such other enabling powers under Odisha Grama Panchayat Election Rules, 1965 and Odisha Panchayat Samiti Election Rules, 1991 directs that the name of the persons duly elected uncontested declared by the Election Officers shall be published on 30.04.2021 as per Commission's Notifications dated 22.03.2021.


