Now, therefore, in exercise of powers conferred under Article 243K of Constitution of India and Rule 76 of the Odisha Grama Panchayat Election Rules, 1965 the State Election Commission hereby appoints the following dates & time for holding Election to the office of Naib Sarpanches where there is failure of election on 11.03.2022 due to lack of majority of the member of the Gram Panchayat present at the meeting;


