


1. The model code of conduct issued by the Commission will remain in force in the concerned Zilla Parishad Constituency from **21.04.2022** to **28.05.2022**.
2. Form No.17 will be submitted to the State Election Commission by the Political Parties within 7 days of issue of this notification i.e by **5.30 PM of 28.04.2022** by those who have not submitted the same by 18.01.2022 during General Elections to PRIs, 2022.
3. Those Political Parties who submit Form No. 17 to the Commission by the dateline are required to submit Form No. 18 to the concerned Election Officer before **11.00 AM of 04.05.2022**.
4. Biju Janta Dal whose candidate died may submit Form No.18 to the concerned Election Officer before the date and time of Scrutiny of nomination Papers i.e **before 11.00AM of 04.05.2022**.
5. The Nomination of contesting candidates except the deceased whose names have been published u/r 14(7) on the previous occasion i.e on 25.01.2022 shall remain valid. They need not file nominations again and they shall be intimated about the election schedule.
6. Withdrawal of candidature is permissible only for the candidates who file nomination as per this Schedule.
7. Allotment of symbol shall be done afresh in Odia alphabetical order.
