Issue of Govt. Notification under Section 12(2) of the Odisha Municipal  
Act, 1950 – Calling upon wards to elect Chair person and Councillors –  
Recommendation of this Commission thereof.

Sir,

In partial modification of Commission's letter No.558 dtd.20.02.2023, I am directed to say that the tenure of Attabira NAC, Hindol NAC will expire on 12.04.2023. The election to these NAC has to be completed before that date. The ward wise preliminary Electoral Roll of these NACs have already been published by the concerned Election Officers. Section 12(2) of the Odisha Municipal Act, 1950 provides that for purpose of election under sub-section (1) the State Government shall by one or more notifications published on such date or dates as may be recommended by the Election Commission, call upon all wards in the Municipal area to elect Chair person and Councillors in accordance with the provisions of this Act and of the Rules and orders made there under.

Therefore, in pursuance of the said Section, the State Election Commission recommends the Government to issue notification under Section 12(2) of the Odisha Municipal Act, 1950 by **24.02.2023** calling upon all the Wards in the Attabira NAC, Hindol NAC to elect Chair Person and Councilors. The copy of the notification published in Odisha Gazette may please be furnished to the Commission on the same date.

The Commission will notify the detailed programme of the election to the said NACs under Rules 23 of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and conduct of Election) Rules, 1994 upon receiving the publication of notification as above from the Government.
