


Sub: Voting by a Voter on Polling duty at another Polling Station within same NAC/Municipality/Corporation.

Whereas in pursuance of Rule 57-G of Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Elections) Rules, 1994 and Rule 63 of Odisha Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Elections) Rules, 2003 if a voter on election duty who is registered as an elector in the NAC/Municipality or Municipal Corporation chooses to vote in person at the polling station where he is on duty on the day of polling, he should send a application to the Election Officer in the Form prescribed by the Commission;

And whereas the Election Officer on receipt of the application shall issue a certificate in Form of Authorisation to vote at a polling booth other than the one where he is enrolled as a voter to the person concerned entitling him to record his vote at the polling station where he is employed as Presiding Officer or Polling Officer or Polling Agent;

Now, therefore, the Commission in exercise of powers conferred under Article 243-ZA of the Constitution, direct that the voter on election duty which includes Polling Agent duly appointed by the contesting candidate shall send an application in the Form annexed prescribed by the Commission to the Election Officer so as to reach the Election Officer at least **four days** before the date of poll.

SUBJECT—Appointment of Polling Agent during poll and counting in the ensuing Municipal Elections.

Madam/Sir,

I am directed to say that as per the definition contained in Rule 2(h) of Orissa Municipal (Delimitation of Wards, Reservation of seats and Conduct of Elections) Rules, 1994, Polling Agent means a person duly authorized by a contesting candidate for whom votes are polled during the election in respect of one or more polling stations or places specified for counting of votes. A candidate can appoint the polling agent with the prior approval of the Election Officer. Similarly, a candidate can also appoint **one representative to be present at the time of counting** of votes under Rule 58 of the said Rules. With the prior approval of Election Officer, No form of appointment of Polling Agent/Counting Agent has, however, been prescribed in the Rules for the purpose.

In order to ensure uniformity, the State Election Commission has prescribed a form for the purpose, a copy of which is enclosed. The said form shall be submitted in duplicate duly filled in by the candidate to the Election Officer concerned before 5 P.M. of the date immediately preceding the date fixed for poll or counting, as the case may be. One copy of the form will be retained in the Election Officer's office and the second copy shall be given to the candidate or his Polling Agent or Counting Agent. **The Election Officer must ensure that the candidate/Polling Agent/Counting Agent should sign in full on the form prescribed by the Commission.** The appointment order shall be presented by the polling agent to the Presiding Officer concerned at the booth/counting hall.

Madam/Sir,

I am directed to say that after careful consideration, the State Election Commission has been pleased to revise the remuneration to polling and counting personnel and for booth arrangement as follows for the General Elections to Urban Local Bodies.


**(A) Remuneration to Polling Personnel**

2. These rates are applicable for attending training classes.
3. The Commission has further ordered that road mileage at the rate prescribed in Odisha T.A. rules shall also be paid if the Polling and Counting personnel are drafted from outside.






4. Polling and Counting personnel deployed at the polling station shall be paid Rs.150/- per head towards refreshment charges on the day of poll and counting respectively.
5. Refreshment charges may be provided to the staff engaged for counting with a ceiling limit of Rs.10,000/- only for Municipal Corporations Rs.8,000/- only for big Municipalities like Puri and Balasore Rs.4,000/- only for other Municipalities/ NACs.
6. The Executive Magistrates /Sector Officers and other staff deployed for maintenance of law and order and other supervisory arrangements during the election will be paid Rs.300/- per day.
7. On the day of Election of Deputy Mayor and Vice Chairperson an amount of Rs. 1,000/- only may also be spent towards contingency.
8. The Drivers of Govt. Vehicles requisitioned for election works shall be paid Rs.130/- per day.

2. In case of difficulty on part of the Presiding Officers to produce vouchers for the petty items of expenditure a certificate (Certified that Rs. \_\_\_\_\_ has been spent to meet the various contingencies for the smooth conduct of poll, dated signature of the Presiding Officer with Municipality/NAC/Corporation and Ward/ Polling Station number) should be given.
  3. The entitlement for attending training may be paid soon after the training is over.
  4. The amount due to the polling personnel in respect of each polling station together with the Acquaintance Roll prepared by the Election Officer will be made over to the Presiding Officers concerned from the respective dispersal counters. After the poll , the Election Officers will receive back the Acquaintance Rolls together with the undisbursed amount, if any, from the Presiding Officer concerned along with the returnable polling materials
  5. The remuneration to the polling personnel will be disbursed by the Presiding Officer concerned after the closure of poll. The remuneration to the reserved polling personnel who are not deputed for polling duty will be disbursed to them at the dispersal center before they are relieved.

6. The Acquaintance Roll for the remuneration for counting duty will be prepared by the Election Officer and the amount will be disbursed at the counting station after the counting is over.
  7. Unspent balance, if any shall be refunded in to Treasury immediately after the elections under intimation to the Commission.



Sanction of remuneration to the Police personnel.

Sir,

I am directed to say that the Commission has been pleased to approve the following rates of remuneration of various categories of police personnel, Home Guards deployed on polling duty and the manner of disbursement of such remuneration shall be as under.


**A. Rate of Remuneration**

SL. No.	Category of staff	On the day of Poll	Other day
1	ASI & Above Officers	Rs.350/-	Rs.250/-
2	Armed and Civil Police Constables	Rs.275/-	Rs.200/-
3	Forest Guards and Grama Rakhis	Rs.200/-	Rs.150/-
4	Home Guards	Daily call Allowance (DCA) as prescribed by the Government.	Daily call Allowance (DCA) as prescribed by the Government.

The above rate of remuneration will be applicable to the Officers and staff attached to polling party at the polling station and will also be applicable to the personnel deployed on mobile parties.

TA/D.A for Constables/Home Guards etc. attached to each polling party would be paid at the above rate by the District Magistrate concerned from funds placed by the commission.

In the sensitive, hypersensitive booths, if more constables/ Police Personnel are deployed for law and order duty (other than the polling party) they would be paid remuneration by the D.G. Police for which funds have been placed separately. It is clarified that only one Police Personnel either ASI/ Constable/Gram Rakhi/Home Guard will be paid by the District Magistrate concerned to each booth.



**B. Food packet cost on polling day and law and order duties.**

Persons deployed on poll duty and counting duty shall be paid @ Rs.100/- per day towards refreshment cost on the day of poll and counting by the District Magistrate concerned.

**C. Mode of payment of Remuneration.**


The above rate of remuneration will be applicable to the Officers and staff deployed on election related duty at polling Station and will also be applicable to the Personnel deployed on Mobile party. The payment of remuneration of Persons belonging to the categories 1 & 2 and Grama Rakhi's (included in category 3) who are attached to polling parties shall be made by the District Magistrate through the Election Officer. Payment of remuneration of all other personnel who are on poll duty but are not attached to any polling party shall be made by the Director General of Police, Odisha through the District Magistrates and District Superintendent of Police.

The number of persons belonging to each of the above categories who shall be attached to polling parties and who shall be assigned other poll related duties shall be worked out jointly by the District Magistrate and the Deputy Commissioner of Police/District Superintendent of Police.

The Superintendent of Police shall earmark an Officer not below the rank of Inspector of the Police from the District Establishment to liaise with concerned Election Officer and furnish him names of persons belonging to each of the above mentioned categories and details of the polling stations to which such persons are being attached to enable the latter to make advance payment to such person towards their remuneration and refreshment cost before they proceed to their assigned Polling Station.



The Commission has decided that candidates contesting for the office of Chairperson/Mayor will also file affidavit as prescribed in Commission's aforesaid order.

2. Non-furnishing of affidavit shall render the nomination of the candidate liable for rejection. The Election Officer should be careful to issue the format prescribed by the Commission at the time of issuing the nomination paper to the contesting candidates.

3. The candidate shall be asked to furnish a copy of the affidavit either Xeroxed/typed or handwritten and signed by him which must be compared by the Election Officer with the original affidavit and after authentication by the Election Officer, the same shall be displayed in the Notice Board for wide dissemination.



4. A copy of the affidavit shall also be uploaded in the District website and / or in the website of the ULB.


5. In case of any shortcomings noticed in the affidavit, the Election Officer shall allow the candidates to take back the same on proper acknowledgement for rectification and re-submission within the period prescribed for filling of nomination.

I am directed to say that Rule 72 (1) of the Odisha Municipal (Delimitation of Wards and Reservation of Seats & Conduct of Election) Rules, 1994 and Rule 85 (1) of the Odisha Municipal Corporation (Division of city into Wards, Reservation of Seats & Conduct of Election) Rules, 2003 stipulate that every Councillor/Corporator wishing to cast his/her vote for the office of Vice- Chair person/Deputy Mayor, as the case may be, shall be supplied with a voting paper on which names of all candidates shall be mentioned both in English and Odia. A format has also been prescribed under the above Rules for Preparation of "voting paper"

Further, the Commission taking into consideration Rules 43 of Odisha Municipal (Delimitation of Wards and Reservation of Seats & Conduct of Election) Rules, 1994 (which governs the preparation of ballot papers) and the corresponding provision in the Odisha Municipal Corporation (Division of city into Wards, Reservation of Seats & Conduct of Election) Rules, 2003 has Ordered that the names of the candidates shall be arranged in alphabetical order in Odia and below each name, the said name shall be written in English. Sufficient space between one candidate and the other, and against each name in Col -2 for placing the cross mark, be provided.

whereas under sub-section(4) of the said Section 17A, the accounts are required to contain such particulars as may be prescribed by the Commission; and

Whereas, the Commission has revised limit on expenditure that may be incurred by a candidate vide Notification No. 2032/SEC dated 06.02.2022;

Whereas, the Commission, vide its Notification No.2275, dated the 2<sup>nd</sup> June, 2008 has prescribed the format and the particulars for maintenance of such accounts by a candidate; and

Whereas, in pursuance of sub-section(5) of the said Section 17A, every candidate is required to lodge with the Election Commission, the said accounts of election within one month from the date of the declaration of results of election.




